Membership Rules

1. Members may make one reservation up to one week in advance (1.5 hour long)
2. Members may make two additional reservations no more than 48 hours in advance (1.5 hour long)
3. All other open court play will be on a “walk-in” basis
4. Reservations are abandoned if both players are not present within 10 minutes following the reserved time
5. A family is defined as a husband and wife or couple, including children under the age of 21 living, under the same roof
6. Monthly Membership fees will be charged to the Member’s credit card during the first week of the month
7. Members may cancel their membership at any time **with written notice** and will not be charged monthly membership dues if the written cancellation is received before the 25th of the month. Members will be able to play out their remaining two months on deposit, if applicable. There are no refunds for membership dues and deposits.
